Honoring the Leadership of PCSI President & CEO Carroll Schubert

ADVOCATE FOR VETERANS AND EMPLOYEES WITH DISABILITIES RETIRES AFTER 25 YEAR LEADERSHIP

March 2021 – For 25 years, Professional Contract Services, Inc. (PCSI) President and CEO, Carroll Schubert, has dedicated his leadership position to champion opportunities for veterans and people with disabilities and for the AbilityOne program.

One of Carroll's most notable and proud accomplishments is his work on the 898 Panel Recommendations. As the committee chair on four initiatives, his leadership was critical in the successful response to the 898 Panel. With the current AbilityOne definition for an individual with a significant disability being outdated, Carroll led the efforts to develop the new definition and reported the changes out to the 898 Panel and the AbilityOne Commission. The new definition was accepted and will now be entered into law as the AbilityOne definition for a person with a significant disability.

committees Additional that Carroll has successfully led include: Completion of the IEE Form, the Veterans Employment Initiative, and the creation of the Individual Development Career Plan (IDCP) as part of his close work with the DoD 898 panel. Per the recommendations of AbilityOne, Carroll identified a solution and was instrumental in creating an innovative platform to empower, motivate and allow individuals with disabilities to expand their career path. Because of the newly created IDCP, AbilityOne NPAs will now have the tools to empower their workforce to experience individual career growth, while hurdling barriers related to his/her disability.

Carroll has spearheaded tremendous job growth at PCSI since his inception as CEO in 2011. Today, we employ 1,700 people at 27 sites across 11 states and raised the average wage for direct labor to far exceed the national minimum wage. Wanting to ensure that people with disabilities are afforded the same benefits as people in the commercial market, Carroll has worked tirelessly to ensure our team members are planning for their future by investing in our company's matching 401K program.



Understanding that individuals with disabilities continue to be the underutilized population in their community, under Carroll's guidance PCSI established its own Community Employment Program (CEP). CEP is creating jobs by building partnerships with schools, students, caregivers, vocational rehabilitation services, and businesses. To date, PCSI has placed 1540 individuals with disabilities in competitive integrated employment with prominent companies including: Amazon, Home Depot, Dollar General, Lowes, Six Flags, Marriott Global, Family Dollar, UPS, and Frito-Lay. With the motto of "So That No Person is Left Behind", he's led the efforts to ensure that people with every type of disability has employment options that lead to independence.

Transitioning students with disabilities into jobs is yet another area where Carroll dedicated resources and advanced our mission. In 2014, PCSI partnered with ProjectSEARCH, a one-year, school-to-work program for students with intellectual and developmental disabilities. The program's success depends on organizations like PCSI that become licensed partners to place students in appropriate internships in local businesses. To date, 64 students have been hired into full time competitive employment, thanks to PCSI's partnership with ProjectSEARCH.

Carroll's innovative approaches and commitment to serve our population have led to him receiving countless accolades and awards from leading organizations

including: Children's Association for Maximum Potential, Camp for All Foundation, Habitat for Humanity, Morgan's Wonderland, Texas School for the Deaf, and Star Group-Veterans Helping Veterans. His efforts have impacted many individuals with disabilities from all walks of life.

We're grateful to have served under such a tireless leader who's always put our mission first and never ceased an opportunity to empower people with all types of disabilities. We will be sad to see Carroll retire this spring and wish him all the best!
